

In consideration of being allowed to play and/or practice in the **OPEN BAYS** at Mygolf Dubai

I acknowledge and agree that:

- 1. I acknowledge and fully understand that my activities at Mygolf Dubai, in the mentioned above area, may involve the risk of injury, including the possibility of serious injury or death, not only from my own actions, but also from the actions or inaction of others, the condition of the premises, or the failure of the equipment used. I knowingly agree to assume all such risk, known and unknown, and assume full responsibility for my participation.
- 2. I agree to conduct myself during the activity with all due regard to my own safety and the safety of all participants, observers, and bystanders. I agree to comply with the directions of all Mygolf Staff.
- 3. The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious. The state of medical knowledge continues to evolve, but the virus is believed to spread through airborne particles, person-to-person contact, and contact with contaminated surfaces and objects. People can be infected and show no symptoms and therefore spread the disease. Evidence has shown that COVID-19 can cause serious and potentially life threatening illness and even death.
- 4. I understand that Mygolf Dubai cannot prevent me from becoming exposed to, contracting, or spreading COVID-19 while attending my activities inside the premises. It is not possible to prevent the presence of the disease at a venue open to the general public. I understand that by choosing to play/ practice at Mygolf Dubai, I may be exposing myself to and/or increasing my risk of contracting or spreading COVID-19.
- 5. I have read and understood the warning contained in Paragraphs 3 and 4 concerning COVID-19. I understand the risks associated with being in a public space and contagious viruses may be present. I hereby choose to accept the risk of contracting COVID-19 in order to perform my activity at Mygolf Dubai.

I hereby forever release and waive my right to assert a claim or bring suit against Mygolf Dubai, including its employees, directors, managers, trustees, or other representatives, from and against any and all liabilities, claims, expenses, or causes of action of any kind or nature whatsoever, arising out of or relating to my activities in the OPEN BAYS at Mygolf Dubai.



- 7. I hereby forever release and waive my right to assert a claim or bring suit against Mygolf Dubai, including its employees, directors, managers, trustees, or other representatives, in connection with exposure, infection, and/or spread of COVID-19 related to attending my activities at the venue.
- 8. I understand that this release and waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence, including the sole negligence of Mygolf Dubai, and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.
- 9. I agree to abide by any policies and procedures established by Mygolf Dubai for participation in my activity, including policies and safety measures intended to mitigate exposure to COVID-19.
- 10. I understand and agree that the law of the State of Dubai will apply to this release and waiver.
